

He has spent almost 35 years working in corporate environmental management and sustainability as in-house or external advisor to Fortune 500 and privately held multinationals in diverse industries and geographies. His work includes environmental/CSR/ESG program evaluation and development, supply chain diligence and sustainability assessments, ESG/CSR data verification reviews as well as performing numerous types/forms of audits. Frequently speaking out against groupthink in the sustainability/CSR consulting community, he has given hundreds of talks on sustainability, supply chain matters and auditing. He has



advised the US Securities and Exchange Commission, US Department of State, US Government Accountability Office, US Department of Commerce, the Organization for Economic

Cooperation and Development (OECD), and industry associations in primary metals, electronics and auditing. He is a member of the Association of Certified Fraud Examiners and serves on the Advisory Board of the Institute of Internal Auditors' (IIA) Environmental, Health & Safety Audit Center, advising the organization on emerging sustainability, CSR and ESG issues.
